

## Terms of Reference (ToR) for Impact Study of Local Rights Programme (LRP) 29, Bajura

### 1. Background and Overview

ActionAid Nepal (AAN) is an anti-poverty, human rights-based organisation established in 1982. It is a non-governmental national social justice organisation rooted and working locally in different parts and regions of Nepal. It is a member of ActionAid International federation. AAN is also part of both national and global social justice movement and, other civil society networks, alliances and coalitions.

This impact study aims at assessing the progress of so far and appraising the performance and capacities of the partners to deliver the desired change. As our long-term partnership with Local Rights Programme (LRP) 29 is going to end after December 2022, it has been deemed necessary to evaluate the progress made so far with special focus on the changes brought about in the lives of the people in the programme areas.

### 2. Objectives and Scope of Work

The study attempts to understand and critically assess the changes brought about by our Human Rights Based Programme. It also assesses how this partnership programme is contributing to achieve our objectives. This change will primarily be measured in the following aspects / areas of change:

1. Analyse which theory of change worked and how and which didn't work and why?
2. Analyse change brought in the lives of (People Living in Poverty and Exclusion P(LiP) through our intervention. The following areas of **changes** should be covered guided by the broader partnership objectives:
  - i. Analyse change in the conditions of the PLiP (in terms of women leadership and their social, economic and political condition)
  - ii. Analyse unequal power relations and ability to challenge different forms of exploitations (how power structure changed)
  - iii. Analyse changes in policies, practices, attitudes and behaviours of state and non-state actors in favour of PLiP
  - iv. Analyse changes from programme impact framework (4Rs – Rights, Redistribution, Representation and Resilience)
3. Analyse effectiveness of the partnership (governance, accountability relations)
4. Analyse alignment and effectiveness of systems and policies (finance, sponsorship, M&E)
5. Analyse child sponsorship mechanism
6. Analyse performance with investment, cost effectiveness (Value for Money) and sustainability
7. Analyse complain handling/SHEA and Safeguarding mechanism
8. Generate learning, challenges and recommendations

### 3. Intellectual Property

### 4. Expected Methodology

The process will be developed in such a way that the evaluation becomes an effective learning process. In order to get an independent view, the study will be led by an external evaluator with

active input from PLiP, partners and concerned staffs from AAN. The external evaluator will preferably be acquainted with adequate experience in assessing human rights-based issues and with a gender perspective.

The process will include comprehensive field interactions with concerned PLiP. Interactions with various local level stakeholders – government and non-government, media –will also be carried out. Efforts will be made to capture the views of these stakeholders on AAN’s approach in securing rights of PLiP. The study will also involve reviewing the secondary information from various sources.

Group discussion, individual interview, case studies, key informant interview, interview/group discussion with concerned stakeholders are the major tools to gather information. Participatory tools i.e. social map, Venn diagram, time line, transect walk etc. will be used wherever applicable. SWOT analysis of the partner organisations will be done to assess the strength and area of improvement of the partner organisations. An overall timeline of the partnership work can be drawn out together with key partner focal persons and mobilisers to understand how changes had happened, and the factors that triggered such changes. Thorough consultations will also be conducted with concerned members of AAN and partners of LRP 29.

Overall, the consultant will be responsible for drafting and finalizing the Impact Study report whereby incorporating the field observations and findings as per the reporting framework mentioned in this ToR. The consultant will also include an annex table that summarizes key findings from impact study. Once the field work is done and report is drafted, the consultant will have to share the preliminary findings with AAN team and the relevant inputs and suggestions should be incorporated in the report.

## 5. Budget and Expected Deliverables

The total budget allocated for this task is 5 lakh rupees. The Consultant would work closely with Organisational Impact and Communication team, the concerned AAN staffs and partners as required. The Consultant should first submit a draft report in electronic copy for impact study to AAN as per the agreed schedule. The AAN concern staffs will review it and provide comments/inputs/feedbacks/suggestions to the Consultant. The Consultant will incorporate the comments/suggestions and submit the final version of the report electronically as well as in hard copies in the given time frame after receiving comments/inputs/feedbacks/suggestions from AAN.

## 6. Timeframe

The time period for these studies is expected to be of 8 weeks with tentative 30 payable working days. The impact study will be started from 1<sup>st</sup> week of September and the final report is expected in the 1<sup>st</sup> week of November 2022. The schedule should be as per the details given below:

## 7. Reporting
