The Asia Pacific Alliance for Disaster Management (A-PAD) is a trans-national disaster aid alliance that works to facilitate cooperation and understanding between governments, private companies and NGOs/CSOs in the Asia Pacific region.

Asia Pacific Alliance for Disaster Management (A-PAD) Liaison office in Nepal is implementing **Disaster Risk Reduction and Strengthening Programme Through Community Resilient and Multi-stakeholder Engagement (DRISTE)** to ensure the multi-stakeholder contribution and engagement for Disaster Risk Reduction and Management especially from private sectors. The project supports for resiliency of disaster-prone communities by improving capacities and information dissemination system to optimize resources.
