

## **TERMS OF REFERENCE (TOR)**

### **Consultant for Subsector Analysis Workshop under Livelihood Technical Assistance Project**

#### **Background**

ActionAid is a global justice federation working to achieve social justice, gender equality and poverty eradication. It was founded as a charity in 1972, and throughout its history, it has innovated and evolved its approach to better address the structural drivers of poverty and injustice. ActionAid believes people living in poverty and exclusion have the power within them to create change for themselves, their families and communities and ActionAid is a catalyst for that change. ActionAid International Nepal (AIN) has been working in Nepal since 1982.

ActionAid International (AIN) Nepal is implementing Livelihood Technical Assistance Project (LTAP) with the objective of increasing households' income of the Harwa Charwa (HC) through increased agriculture production and access to loan investment in partnership with Freedom fund in Siraha, Saptari and Dhanusha District. The project is currently being implemented at 22 different municipalities/ Rural municipalities of these districts. AIN is seeking a consultancy under the project where about organization is going to organize one day sub-sector analysis workshop with the presence of key members of Harwa Charwa Groups. This workshop will be conducted with the selected beneficiaries in each district and identify the opportunity, constraints, risk with seeking areas of coordination and collaboration with the local level stakeholders and technical input to address the issues by project side.

#### **Objectives**

- To identify and analyze the subsector sectors of agriculture and livestock in working areas.
- To find out the opportunity, challenges and risk and areas of support to be provided project to address the of subsector's challenges and risks.
- To recommend potential sectors for conducting technical training in agriculture, livestock, and small-scale enterprises related with.
- To analyze the areas of collaboration and contribution among beneficiaries, service providers and other stakeholders for the effective implementation of project.

#### **Scope of Work**

The scope of work requires a consultant who has in-depth understanding on agriculture/cash crops and livestock and other livelihood opportunity in the Terai region. He/she should be well known and aware of existing practice of vegetable farming and livestock rearing system of Nepal.

#### **Deliverables**

The following deliverables are expected from the consultant in due process of the assignment:

- Develop a concept/PPT slides of agriculture and livestock subsector analysis related to the terai region.
- Content should include sub sectors of agriculture and livestock in terai region, Challenge and opportunity of subsectors and which sectors is possible to implement in local level for livelihood assistance project.
- Identify the role and areas of support to be provided by project to address the challenges and gaps.

- Deliver one-day workshop in all three districts to project staff and key Harwa Charwa group members.
- Provide a constructive report after delivery of training sessions in English.

### Duration

- 4 days engagement of a consultant – 3 days for workshop delivery (one day in each district) and 1 day for preparation and reporting.
- The task development and delivery of the above-mentioned content and delivery of the training sessions and reporting need to be completed by 15th December 2023.

### Reporting

The consultant will work closely with and report to Programme Coordinator-East in ActionAid International Nepal.

- Extensive knowledge on social inclusion, the issue of Harwa Charwa and local policy regarding grant/ subsidy distribution by local, provincial, and federal group.
- Excellent report writing skills in both English and Nepali.
- Speaking and delivering the content in Maithili language is highly preference.
- Strong leadership skills: ability to influence others.
- Ability/desire to share best practices/key learnings (good & bad).
